TES reserves the right to revise these terms and conditions from time to time at our discretion. Such revisions will be effective immediately upon publication on this website. We recommend the purchaser reviews the terms for amendments each time you use the website and before placing any order. The purchaser's continued usage of the website following any amendment of these terms represents an agreement by the purchaser to be bound by these terms as amended.

### **Pricing**

Prices will be as specified in the TOA Online Store, as determined when ordering online in Singapore Dollar ("SGD"). Prices will include the applicable goods and services taxes ("GST") as at the date that the order is accepted by TES and sales has been processed and concluded;

TES reserves the right to change prices published on the TOA Online Store at any time including, in respect of an order, at any time prior to acceptance of that order by TES. Prices are valid until amended or removed from the website and are subject to change at any time;

TES reserves the right to correct the price at any time prior to self-collection or delivery where there has been a typographical or other error in the price. TES or TES authorized dealer will notify the purchaser of the corrected price. The purchaser may choose to pay the corrected price, however, if the purchaser does not choose to pay the corrected price, then TES or TES authorized dealer(s) have the right to cancel the order without further obligation to the purchaser;

Prices quoted do not include delivery. Delivery options may be offered to the purchaser by TES or TES authorized dealer(s) at additional cost.
